City of Bayard \$11,720,939.76

SECTION 2. There is hereby appropriated to the respective funds of said City such sums as shall be paid to the County Treasurer of Morrill County, Nebraska, during the ensuing year for taxes and previous fiscal years for such respective funds and there is also appropriated all occupational taxes collected for and during the fiscal year; also unexpended funds in the hands of the City Treasurer at the beginning of the present fiscal year hereby appropriated to be used to defray the expenses or obligations of the City chargeable against said City funds.

- 1. It has been a busy week at the Villa! Last week CMS announced that they would be coming out with new testing guidelines. They became a rule yesterday. Depending on the positivity rate in the nursing facilities county (which CDC figures differently than our health districts because they use a different denominator), will determine the facility's testing frequency. Morrill County is at 6.2%, we now have to test weekly. (If the rate was below 5%, then we are only required to test monthly. CMS has mailed out POC test kits to every facility in the nation. As of yesterday, 48ish facilities in Nebraska had received theirs, us NOT being one of them. So we must document that we don't have our machine and kits so we can't test and then try to find an alternate way to test. We've been told by the State and PPHD not to use testNebraska yet, because it would overwhelm them. So I will be talking to MCCH to see if they can test us. We should receive our kits this week.
- 2. If we have one positive that is considered an outbreak, then we have to test everyone every 3-5 days until we don't have a positive for 14 days. If the county's positivity rate goes above 10%, we have to test twice a week.
- 3. CMS wants a 48 hour turn around period. testNebraska has a 3-5 day turnaround period, so we just need to document that. As soon as our kits get here, we'll be fine. Although there is not an indefinite supply of test kits, so we will have to purchase those. I've heard they are \$24-32/test, but I honestly have no idea. We have to test EVERYONE that enters the building?
- 4. The compressor on an RTU went out. We are getting a few bids. The last one was 12k.
- 5. The Fire Marshall was here 9/3 for the ALF. There was a closet that had items stacked too high, but in all reality, the shelf is too high anyway and shouldn't be used for storing items.
- 6. They are installing our new phones!!
- 7. Work has begun on wireless upgrade.8. We are taking the residents to the golf
- 8. We are taking the residents to the golf course for lunch and out to Schmunk's pit to fish.
- 9. We received our SOD (statement of deficiencies) today. We were cited for this at our annual survey, so not really happy to have to rewrite a plan of correction. I also sent the letters we received and the 2567 for your viewing.
- 10. Staffing....an agency night nurse and 2 agency night aides. We did hire a PT noc RN that started this week. Still trying to replace the aides that are going to school. We also need a couple housekeepers and a dietary aide.
