Ingram, the company that issues the books to the library notified Director Henkel that there will be a \$2.50 fuel surcharge for every delivery. Director Henkel attended a job fair at the Bayard High School where she had a booth and took applications for the Summer Internship. On May 3 Director Henkel had a booth at the Elementary School and handed out fliers for the summer reading program and story time. The summer reading kick off will be May 26 in the gazebo in the Library Park. Entertainment includes a pirate and snow cones. Summer school will share the costs of the entertainment. On June 2 for the Summer Reading Program, the Bird Conservancy of the Rockies will do a workshop with the children aligning with the theme for the Summer Reading Program, "Oceans of Possibilities." The Summer Reading Program will run from May 26-July 21 with Story Time running from June 7-July19. The Library received notice that they were approved \$1440.00 through e-rate for internet expenses.

Summer Internship: The board discussed the applications for the Summer Internship.
